All the DROMEX 3000 series masks are suitable for use against solid & water based liquid aerosols and comply with the requirements of the PPE directive 89/686/EEC. These 3000 series disposable masks are designed for comfort and performance during the complete 8hour design period and beyond. The flat fold mask is Dolomite tested for resistance to clogging and has an exhalation valve for ease of breathing.

Packaging, Storage & Obsolescence:

3231 - Packed 12 masks individually sealed in plastic packets in a box and 20 boxes in a carton for shipping. The masks are NRCS homologated for boxes of 12.

Store in a cool dry place. The expiry date of each item is indicated on the cartridge.



Cleaning & Maintenance:

This is a disposable item so no cleaning nor maintenance is required.

Special Instructions:

All respiratory selection should be read in conjunction with BS EN 529:2005 "Respiratory Protective devices – Recommendations for selection, use, care and maintenance".

Do not use these respirators or enter in area where:

The Oxygen concentration is not known or is less than 19.5%.

Contaminants or their concentrations are unknown or are known to be immediately dangerous to life or health.

Particulate concentrations exceed levels fixed by the applicable health and safety regulations or protection factor 50.0 NPF whichever is lower.

Gases and/or vapours are present except for respirators designated as protecting against vapours, in which case vapour concentrations should not exceed 50.0 NPF.

The requirement for leak tightness is unlikely to be achieved if worn against a beard or facial stubble.

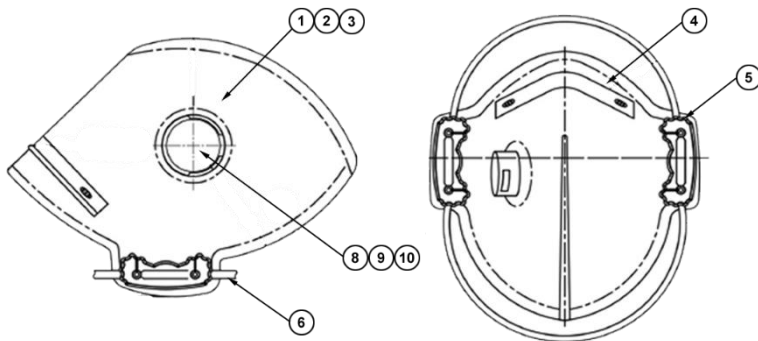

- 1 115gsm Polyester fabric.
- 2 P3 Melt Blown filter medium.
- 3 42gsm Polypropylene non-itch mask body.
- 4 White plastic coated nose bridge adjuster.
- 5 HDPE head band adjuster.
- 6 Elastic head band.
- 7 Foam Nose comfort strip. (not shown)
- 8 Polypropylene valve seat.
- 9 Polypropylene valve cover.
- 10 TPR valve diaphragm.
